Penn Township Rezoning

Protect PT keeps residents informed

This October, when Penn Township put rezoning on the Planning Commission's agenda, Protect PT sprung into action by alerting residents in the impacted area to the proposed changes to their community going on without their input. Through sustained outreach and community engagement, Protect PT has played a large role in the 100+ residents that have been showing up to Board Planning Commissioners and Commission meetings, demanding transparency from the Township.

Without residents stepping up when we sounded the alarm, the Township would have most likely already passed a new ordinance and rezoned a large portion of the northeastern corner of the municipality from Rural Resources to Industrial Commerce, all without resident input. The dramatic zoning shift would negatively impact those living near the proposed rezone area, shocking the rural residential community with loud industrial development that would most likely contribute to excess pollution for those who have called PT home for generations.

But now the Township's timeline has shifted, thanks to residents standing with Protect PT. To stay updated on the Township's timeline and prepare for the public hearing likely to take place this February, go to protectpt.org/rezone.

Local Well Pad Trial

Drakulic Hearings to begin this January

The Environmental Hearing Board (EHB), the adjudicative body that hears appeals from permits granted by the Pennsylvania Department of Environmental Protection (PA DEP), will begin hearings on January 15, 2025 on the PA DEP's issuance of drilling and operating permits for fracking wells by Apex Energy (PA), LLC at the Drakulic Well Pad.

The Drakulic well pad is located in Penn Township, on the border of Trafford Borough, Westmoreland County. It is situated in the middle of sprawling suburban housing developments where about 3,500 people reside. The site is located about 1000 feet from the residence, about 800 feet from PA State Route 130, and a mile from the Westmoreland Heritage Trail. It is also within a mile of an elementary school and a half mile of at least one children's playground.

"If there is a large fire at the Drakulic site and all those nearby trees that surround homes catch on fire, how are all of us going to be safely evacuated, especially if Route 130 becomes impassable?" asks Larry Irr. a resident who lives about 2,000 feet from the site. "We have seen it happen before," said Irr, pointing to a large well fire in Belmont County Ohio in 2018 where about 100 people living within 1 mile were evacuated by door to door notification. "At the Drakulic well site we are talking about thousands, not hundreds, many families with young kids," said Irr.

Recently, supervisors in Cecil Township, a rural community in Washington County, instituted a 2,500 foot setback from protected structures and 5,000 foot setback for schools and hospitals after residents fracking impacted by development. Residents of Penn Township are not so lucky, even after over 200 residents of Penn Township signed a petition drafted by Protect PT advocates requesting local commissioners increase setbacks.

The EHB hearing regarding the Drakulic well is scheduled to begin January 15th, 2025 and will continue through January 31st. Protect PT will continue working to protect the residents of Penn Township and Trafford through legal action on this case.

Run for Office

Prepare for 2025 local elections

As 2025 is a local election year, Protect PT hosted another non-partisan "How to Run for Local Office" training. We covered how to file your paperwork, how to manage a campaign according to laws and best practices, and how to contact voters.

Sixteen residents of communities all across Allegheny and Westmoreland Counties attended our last session, with potential future officeholders calling in from West Deer, Murrysville, Elizabeth, Penn Township, and other municipalities. Although we are not allowed to engage in political activity, we are allowed to say this much: we are excited by the public's appetite for contributing to their local communities!

New Permits for Violators?

WSL Reapplies for Title V Air Permit

Westmoreland Sanitary Landfill (WSL) has requested a renewal of its Title V Air Quality Operating Permit. Due to the extensive history of environmental and health impacts to the surrounding communities, Protect PT is requesting a public hearing on this matter for the residents living in the vicinity of the landfill, but also for all the residents downwind of the facility in the Southwest Pennsylvania region.

"This facility has been a burden on this community for decades, so residents should be given the opportunity to speak directly to decision-makers and advocate for their health before the permit is issued," said Gillian Graber, Executive Director of Protect PT.

Protect PT has made its own comment to send to the PA DEP but feels that resident voices are the most

important voices to be heard by the state agency. "WSL has continued to fail in its obligations and has not been a good neighbor to the community despite multiple consent orders from the PA DEP," said Dylan Basescu, Staff Attorney for Protect PT. "WSL should not receive a renewed permit to emit even more air pollutants until it has fixed its prior mistakes," says Basescu.

Protect PT is currently working on a comment to the EPA to urge them not to allow the PA DEP to issue this permit. To read more about our work around the Westmoreland Sanitary Landfill, go to protectpt.org/wsl.
